As per provision of section 65(4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report, the Hon'ble Vice Chancellor is pleased to grant of REVISED First Time Affiliation to Government Ayurved College, Baramati, Dist. Pune (Maharashtra) for 100 seats (including EWS) of B.A.M.S. Course for the Academic Year 2022-23 subject to approval of Academic Council as per the provision under section (65) 2 of MUHS Act 1998 by following due procedure.

However, the affiliation is subject to the following conditions: -

- 1) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.

9) The students shall be admitted only after obtaining the permission of concern council / Commission & competent Authority of the State Govt.
